Initial tool aims to foster an open digital-information marketplace that respects user privacy and trustworthy identity, and include developing a federated single sign on (SSO) service and an anonymous user data exchange service. Among objectives of these efforts are to (a) help quality publishers improve the relevance and value of advertising through deeper knowledge about their users' collective interests and (b) create a public-interest internet ecosystem consisting of an individual 'fast pass' for accessing and supporting or paying for trustworthy information.
